#### Introduction

Commission Delegated Regulation (EU) 2020/1816 sets out the requirements for disclosures on how Environmental, Social and Governance (ESG) factors are reflected in each ESG benchmark provided and published by a benchmark administrator.

Where disclosure of ESG factors are listed voluntary in Annex II of the Commission Delegated Regulation (EU) 2020/1816, the detail may not be provided.

For each of the overall factors the corresponding percentage of coverage of the underlying data used for aggregate calculation is disclosed. If data us not available or insufficient for individual ESG factors, they are marked as "N/A" below.

Aggregate weighted average values are restricted to companies where data is reported, companies where data is not reported are excluded and weights are renormalized.
